RULES & REGULATIONS

I wish to be registered with the Club's Masters Swimming Team and I undertake to observe the following rules now in force, subject to any amendments, from time to time:

1. Member's guests must be registered with the Club.
2. I am required to represent the Chinese Swimming Club in all meets as required by the Club.
3. I shall not represent any other clubs in swimming or train in any other clubs.
4. I agree to pay the monthly training fees as stated above and that my absence from lessons does not indicate my withdrawal from the programme unless the Official Withdrawal Form is submitted in accordance with the Withdrawal Procedures below.
5. **Payment: Non-Members** – the completed registration form and payment (training fees and 1 month's deposit – Masters (Guests) must be submitted to CSC by the 25th of the preceding month prior to the commencement of training. With effect from 2024, training fee payment for all guests will be via GIRO deduction. Guests are required to submit the GIRO application at the CSC Front Office / Sports Desk on the first lesson. Non-CSC member trainees who fail to submit the GIRO form and make the payment by the stipulated date shall be deemed to have withdrawn from the Masters Programme.
6. **Payment: Non-Member** – Non-CSC member trainees will be allowed to make their monthly training fees by tagging along the CSC member account with the consensus of the registered CSC member.
7. I understand that Registration / Re-registration Fees and Swimming Fees for Masters are **NON-REFUNDABLE** under any circumstances (*pro-rated refunds will not be entertained*).
8. There shall be **NO training** on **Public Holidays** and there shall be **NO make-up**.
9. The Club reserves the sole right to amend any Terms & Conditions of the operations of the swimming programmes without prior notice.



MASTERS TRAINING PROGRAM

BAD WEATHER / HAZE GUIDELINES

1. Bad weather is defined as lightning or heavy rain within close proximity of the Club. The pools will be closed by the pool management and/or lifeguard and/or CSC staff.
2. Haze advisory:
 - a. PSI 150 & below – lessons as per normal
 - b. PSI 150 & above – lessons will be cancelled.
 - c. The Club will check the PSI level an hour before the commencement of lessons and update the status on CSC website - <https://www.chineseswimmingclub.org.sg>.

WITHDRAWAL PROCEDURES

1. Withdrawal must be indicated in advance via the Google Link prescribed Below:

2. **Withdrawal Forms received by the Club on or before the 15th day of the month will be processed within the month; the training fee for the current month will be debited accordingly and will cease in the following month.**
3. **Withdrawal Forms received by the Club after the 15th day of the month will be processed in the following month; the training fee for the current and following month will be debited accordingly and will only cease thereafter.**
4. Post-dated Withdrawal Forms and verbal requests over the phone or in person will not be entertained.

INDEMNITY
